

EARLY POLICE DEPARTMENT COUNCIL REPORT 1st QUARTER

1. Drone policy created and submitted to tcole – HB-1758 requires all law enforcement that may use a drone to have a policy regulating the use to comply with all FAA rules and all use of force policies and regulations. The policy was copied from IACP (International Association of Chief's Police) and adopted. All policies are due January 1st 2022. Early PD policy was submitted on December 13th, 2021.
2. Racial Profiling reports – Code of Criminal Procedure article 2.131 – 2.138 requires an agency that conducts traffic stops to submit a racial profiling report to TCOLE to be published for public review. The report must include an online questionnaire provided by tcole, a PDF with a comparative analysis of its motor vehicle stops compared to gender and ethnic population of our area. We must also provide a statement if any racial profiling complaints were made against the agency and list the complaints and resolutions. The EPD did not have any racial profiling complaints during 2021.
3. The Emergency Response vehicle purchased through a grant from WCTCOG has been purchased. The vehicle is currently being upfitted with equipment and should be in full service soon.
4. The CID vehicle that was ordered is currently in the shop being upfitted and should arrive soon.
5. Early PD continues to participate in the STEP program each month. STEP is where TxDot pays the officers overtime to work traffic on Early Blvd and Garmon Drive. Officers are required to make 2.5 contacts per hour. Doesn't require tickets issued, either warning or tickets. Officers can still use discretion for each contact. Many times, when you see a lot of traffic stops going on it could be the officer's working STEP. The regular on duty units can spend more time in neighborhoods when not on calls.
